



Reforms under Single Window Clearance System

- Entire Building permit / completion process (Building Plan Approval, Plinth Approval & Completion cum Occupancy Certificate) reduced to 7 procedures and all permits are granted in less than 60 days
 - Common Application Form (CAF), integrating all external/internal agencies
 - Integrated <u>CCZM</u> for all agencies on GIS based color coded map (for ascertaining requirement of NOCs by location)
 - Online Calculator for fee calculation and online payment have been integrated with the Single Window System

Reforms under Single Window Clearance System (SWCS)

- **Risk-Based Classification of buildings** to fast track approval for low risk buildings
- Requirement of affidavits done away with: replaced by a single e-undertaking
- Requirement of No Tax Dues certificate has been done away with
- Building permits issued online with digital signature: No personal visit required

Reforms under Single Window Clearance System (SWCS)

- **COCCRF** (Common Occupancy cum completion Request Form): Single application for inspection and NOC certification
- Road Cutting and restoration charges for water and sewer connections are collected only for a length up to 5 mts
- Joint Inspection by all relevant external agencies and in house departments to issue NOCs for OCC
- Digitally signed Occupancy –cum-Completion (OCC) Certificate issued online

Reforms under Single Window Clearance System (SWCS)

• Provision to submit site photographs, thereby eliminating the requirement of on-site inspection for Low Risk Buildings.

 Decennial Latent defect liability and professional indemnity insurance have been introduced in the UBBL-2016 (Amendment)

• SARAL Scheme : upto a plot size of 105 sq mts intimation by the Architect is acknowledged without any physical visit

• SPECIAL SARAL Scheme : upto a plot size of 500 sq mts intimation by the Architect is acknowledged as sanction without any physical visit.

Recent Reforms

- Reduction in cost of Construction Permit due to waving of Levy and Development Charges for Water & Sewer connection.
- Single Joint Site Inspection by all concerned NOC agencies at time of completion cum occupancy certificate (Fire, DJB and MCD)
- Provision of Insurance of Professional and Building proponents
- Dynamic Dashboard for sanction, plinth inspection and completion cum occupancy certificate.
- > Dynamic Dashboard for external noc agencies in public domain.
- Time for construction permit reduced to 34 days while as per UBBL-2016 it is 59 days.


Steps taken to improve transparency and ease

- Risk Based procedures for Sanction / Plinth Inspection / Completion.
- All <u>FAQs</u>, <u>Circulars</u> and <u>Checklists</u> are available on the websites
- Dynamic Dashboard of all cases projected online on Real-Time basis
- <u>"Then" and "Now"</u> scenarios projected w.r.t April 2016 (OPBAS Go-live)
- Short film on EoDB in Construction Permits

Colour Coded Zonal maps (CCZM)

- To determine the requirement of NOC from external agencies, for a particular property, **Colour Coded Zonal Maps** (CCZM) have been prepared by
 - 1. Delhi Urban Art Commission (DUAC),
 - 2. Delhi Metro Rail Corporation (DMRC),
 - 3. National Monuments Authority /NMA (ASI)
 - 4. Airports Authority of India (AAI)
 - 5. Forest Department
 - 6. Delhi development Authority (DDA)
 - 7. Public Works Deptt (PWD)
 - 8. Railways
 - 9. National Highways Authority of India (NHAI)
- To further streamline the CCZMs, <u>a single superimposed CCZM</u> map has been prepared making it easier to determine the requirement of NOCs.


