Subject Online Module for Addition / Alteration in DDA Flats under EODB.

Under the "Ease of Doing Business" relating to construction permits, the Online Module for Addition / Alteration in the existing DDA Flats has been developed. Henceforth, all the applications for addition / alteration in respect of DDA Flats shall be submitted through Online Mode. The Architect shall fill up the Common Application Form (CAF) through Online Mode and the building permit , may be issued through Online Mode as per the addition / alteration policy notified by the DDA.

As per prevailing procedure, the compounding charges of the existing structure beyond sanction but within permissible limit are to be worked out by the Architect and shall be uploaded at the time of submission of Online Application.
